1. The tabletops will be available for setting-up at 6:30 a.m. on the day of the event. All exhibits must be set by 7:00 am. You may tear down your tabletop after 5:00 p.m. All tabletops must vacate the premises by 6:00 p.m..
2. The exhibit area will be open as follows:

Friday 8:00 a.m. - 4:00 p.m.

The Executive Planning Committee has the right to amend these times if necessary.
3. The PFCC Workshop Series attendees will be free to participate in the exhibit area before and after sessions.
4. Only authorized participants, authors and exhibitors will be admitted in the exhibit hall. The name of the authorized representatives shall be furnished to the exhibit manager not less than ten (10) days before the opening of the conference.
5. The PFCC Workshop Series committee and the Host Facility cannot guarantee exhibitors against loss or damage of any kind, but will endeavor to protect exhibitors by providing standard security protection.
6. Special written arrangements with The PFCC Workshop Series manager should be made in advance if two or more firms wish to exhibit in a single space. There will be an additional fee for this option of sharing space.
7. An exhibitor wishing to release their assigned space prior to 30 days prior to the meeting and after their application has been received will be refunded all but 50%. Cancellations after that time will not receive a refund. All cancellations must be made in writing. It will not be possible to refund any payments made if exhibit space is not used or only partially used.
8. Approval by the PFCC Workshop Series manager should be made in advance if prizes, contests or drawings are to be used.
9. Infractions of these conditions on the part of the exhibitor or any of his/her representatives may subject them to dismissal from the symposium hall. In this event, no demand for redress will be made by the exhibitor or representative.
